

9/11 Whistleblowers



Many people defend the official story of 9/11 because they state that the problem with a cover-up of 9/11 is "that bureaucrats are incompetent and people can't keep their mouths shut."

April Gallop a Top Secret Military Specialist at the Pentagon saw disturbing things up close that have not been reported in the media. On the morning of September 11, 2001, she was ordered by her supervisor to go directly to work at the Pentagon, before dropping off her ten-week-old son at day care. The instant **Gallop** turned on her computer an enormous explosion blew her out of her chair.

Escaping through the hole reportedly made by Flight 77, she saw no signs of an aircraft — no seats, luggage, metal, or human remains. Her watch had stopped at 9:30-9:31 a.m., seven minutes before the Pentagon was allegedly struck at 9:38 a.m.

"Why then were there no anti-aircraft defences", **Gallop** asks, "or alarm warnings inside the Pentagon?" **Gallop** was briefed by officials not to tell her story in public; she also received an email from a Fox News reporter who had been told by the Pentagon not to interview her.

After looking into the new available scientific evidence of 9/11 **Gallop** believes that officials within the Bush Administration conspired to destroy the Twin Towers of the World Trade Centre - with pre-placed explosives detonated after the planes hit. **Gallop** is currently taking a case against Cheney, Rumsfeld and Myers to the United States Court of Appeals in relation to the cover up of 9/11.



Susan Lindauer worked as a US intelligence asset and covered anti-terrorism at the Iraqi Embassy in New York from 1996 up to the invasion.



Independent sources have confirmed that she gave advance warning about the 9/11 attacks. Dr Parke Godfrey, an associate professor of computer science at York University in Toronto testified under oath that several times in early 2001 **Lindauer** warned him that US intelligence expected a major attack on the southern part of Manhattan, and that the attack would cover the World Trade Center and would involve airplanes.

In early 2004 **Lindauer** requested to testify before Congress about successful elements of Pre-War intelligence, and also delivered a letter to her second cousin White House Chief of Staff Andy Card and Colin Powell warning of the dire consequences of War with Iraq. Shortly after, **Lindauer** became one of the first non-Arab Americans arrested under the Patriot Act and was indicted for acting as an "unregistered Iraqi Agent".

After five years of indictment without a conviction or guilty plea, the Justice Department dismissed all charges.

9/11 Whistleblowers



Sibel Edmonds started work as a Turkish and Farsi translator for the FBI five days after 9/11. Part of her job was to translate and transcribe recordings of conversations of suspected Turkish intelligence agents. She was fired from the FBI in April 2002 after she raised concerns that one of the translators in her

section was a member of a Turkish organization that was under investigation for bribing senior government officials and members of Congress. A Department of Justice Inspector General's report called Edmonds's allegations "credible," "serious," and "warranting a thorough and careful review by the FBI."

Despite this the Attorney General asserted a "state secret's privilege" order on her, and she was unable to speak publicly. The 9/11 family members demanded that she give her testimony to the 9/11 Commission. In the end the 9/11 Commission didn't include Edmond's important testimony in their final report.

Edmonds has also described testimony from former FBI Language Specialist, **Behrooz Sarshar**. In April, 2001 **Mr Sarshar**, attended a meeting between a long-term reliable Iranian FBI asset and two additional FBI agents from the Washington Field Office. That FBI asset told the agents that his sources in Afghanistan had information of an al-Qaeda plot to attack America in a suicide mission involving planes. Via his contacts in Afghanistan he had discovered four very significant pieces of information:

- First, Osama Bin Laden was planning a set of terrorist attacks involving some 4-5 US cities.
- Secondly, the attack would use airplanes.
- Thirdly, some of the participants in these attacks were already in the United States.
- Finally, the attack was going to take place within a few months of April 2001.

Thomas Fields, Special Agent in charge of Counter-Terrorism at the Washington Field Office, took no action on the translated material from the Iranian intelligence asset and **Mr Sharsar**, was told to keep his mouth shut about the interview material. When FBI counsel **Colleen Rowley** delivered a now-famous letter to the director, detailing how bureau higher-ups thwarted attempts to investigate accused 20th hijacker, Zacarias Moussaoui, before the September 11 attacks, she set off a firestorm.

Chicago-based special agent **Robert Wright** also accused the FBI of shutting down his 1998 criminal probe into alleged terrorist-training camps in Chicago and Kansas City... **Wright** did say that FBI bureaucrats 'intentionally and repeatedly thwarted his attempts to launch a more comprehensive investigation to identify and neutralize terrorists.' And that 'FBI management failed to take seriously the threat of terrorism in the U.S.'



According to Army reserve **Lieutenant-Colonel Anthony Shaffer**, a top secret Pentagon project code named Able Danger had identified 9/11 ringleader Mohammed Atta and 3 other 9/11 hijackers as members of an al-Qaida cell more than a year before the attacks. Upon trying to relay this message to superiors he was told to discontinue looking into the suspected terrorists, and was prevented from relaying the information to anyone else. After passing this information to the 9/11 commission in 2003, his 20 year long career in the military was destroyed and he was pushed out. "The buildings should have easily withstood the thermal stress caused by pools of burning jet fuel." - **Kevin Ryan** was fired by Underwriters Laboratories (UL) for publicly questioning the company's testing related to the World Trade Center (WTC) steel and fire proofing and its role in the WTC investigation being conducted by the National Institute of Standards and Technology (NIST). UL claimed that there was "no evidence" that any company had tested the WTC steel components.
